**Settlement:**

- **Tender period (T):**  
Trade day and the 1<sup>st</sup> and 2<sup>nd</sup> day after the trade day (T, T+1 and T+2)
- **Delivery period:**  
2<sup>nd</sup> day after the trade day (T+2) or beyond as informed by RSBL eCoins
- **Pay-in of funds:**  
Up to Last Tender day
- **Pay-out of funds and commodities (delivery to buyer member):**  
Up to Last Tender day

**Delivery:**

- **Delivery logic:**  
Compulsory Delivery
- **Deliverable grade of underlying commodity:**  
RSBL eCoins tendering delivery will have the option of delivering such grades as per the contract specifications. The buyer has no option to select a particular grade and the delivery offered and allotted by RSBL eCoins shall be binding on him.
- **Delivery period Payment:**  
Client has to make full payment of the value of the trade in order to take the delivery.

**Legal obligation:**

The clients will provide appropriate tax forms wherever required as per law and as customary and neither of the parties (seller or buyer) will unreasonably refuse to do so.

**Applicability of Business Rules:**

The general provisions of Byelaws, rules and Business Rules of the RSBL eCoins will form an integral part of this contract. RSBL eCoins can further prescribe additional measures relating to delivery procedures, warehousing, quality certification, and margining and risk management from time to time. (The interpretation or clarification given by the RSBL eCoins on any terms of this contract shall be final and binding on the Registered Clients and others.)
